River Ranch Campground - Daily / Monthly / Seasonal Rates

Open mid May thru September, weather permitting.

- * **Tent sites** - on river or hill; dry camping and sites with electric & water; includes use of bath houses.
- * **RV sites** - river and / or stocked lake sites, with or without full hookups, 30 or 50 amp sites, and hillside sites (for monthly or seasonal guests).
- * **Cabins** - very old and rustic; 1,2, or 3 bedrooms; linens not furnished...bring own linens, paper goods, cleaning items or rent from us; cookware and table settings provided; no smoking and no pets.
- * **Lodge Apartments** - All have 1 bedroom with 1 or 2 queen size bed(s); a kitchen provided with cookware and table settings, a living room with fireplace and TV; all linens are furnished; no smoking and no pets.

RIVER RANCH GUIDELINES

- * **Check-In-** 2:00 PM. Check-Out-Promptly at 10:00 am please.
No fishing on day of check-out.
- * **No** refunds for late check-in and or early check-out, and there is an additional charge for late check-out.
- * **Quiet** hours are from 10 PM to 8 AM. Be respectful of others.
- * **Observe** 5 mph speed limit at all times.
- * **Keep** site clean - bag trash and place in trash dumpsters.
- * **Campfires** - attend to fires at all times; no gathering of firewood wood for sale in office; practice fire safety and be considerate of neighbors.
- * **To** keep rates low, rates do not include use of air conditioners electric heaters; therefore, there is a \$5.00 / day additional charge for their use. We hope the honor system works; however if it doesn't camp hosts will monitor and report ac / heater use and your site will be charged accordingly. Please pay daily in office for ac and heater use. THANKS!!!
- * **No** public consumption of alcohol. Consume only at site.
- * **No** swimming, wading, tubing or rock throwing in the lake or river. No chasing or throwing at wildlife.
- * **No** washing of RV's, trailers, vehicles, cycles or ATV's.
- * **No** washing of clothes in bathhouses. Park has a laundromat.
- * **Visitors** - Please hold visits to a minimum (park is for paying guests); visitors must park in designated area in front of office and register with office personnel. Must depart park by 9 PM.
- * **Bear Country** - Don't encourage bear visits. Keep food, coolers, hummingbird feeders, even pets inside vehicle / RV; NM Game & Fish Dept. may enforce rules.

RECREATIONAL VEHICLE SITES

- * **Only** 1 RV per site; max per site is 6 people, including children and babies. RV sites using tents for sleeping will be charged for a tent site.
- * **Use** of sewer ring is required. Must use designated sewers for dumping black and grey water. Do not dump on ground.
- * **Please** do not move fire rings or alter site boundary markers.

TENT SITES

- * **Only** 1 tent per site; max per site is 6 people, including children and babies. Tent sites using additional tents for sleeping will be charged for an additional tent site.
- * **Please** do not move fire rings or alter site's boundary markers.
- * **Be bear aware !!!** Clean grill and discard grease in dumpsters. Keep food, coolers, ect. locked inside and change clothes worn while cooking before retiring.

RUSTIC CABINS 1,2 or 3 bedrooms

- * **Follow** cabin guidelines posted inside entry door of cabins.
- * **Do** not pull out sofa for bed use... it's too close to space heater.
- * **If** renting linen bag(s), remember fresh linens are not provided, so use them wisely. On day of departure, bag and return all linens to office.
- * **If** checking out before office opens, please notify office personnel the day before to make arrangements for cleaning deposit reimbursement.
- * **Refund** of cleaning deposit depends on compliance of " what is expected for refund " list. See posted cabin guideline list.
- * **Take** what is yours and leave what is ours.
- * **Upon** check out, return keys to office or drop in key drop box.

APARTMENTS ... 1 bedroom w/1 or 2 queen bed(s)

- * **Please** follow apartment guidelines posted near entry door.
- * **If** you need clean linens, etc., please request at office.
- * **Please** leave kitchen as clean as you found it.
- * **Please** take what is yours and leave what is ours.
- * **Return** keys to office or drop in key drop box at office

BICYCLES, MOTORCYCLES, ATV's TRAILERS / EXTRA VEHICLES

- * **Bicycles** may safely be ridden between 8 am and dusk only on the office side of the river, and may not be ridden on either river bridge.
- * **Motorcycles** and motorized bicycles may only be ridden from site to campground exit and from campground entrance to site.
- * **ATV** vehicle operation is prohibited within campground.
- * **Trailers** towing ATVs, motorcycles, extra vehicles may be parked in area designated for trailers.

PETS

- * **Pets** must be supervised and on a leash at all times.
- * **Pick** up after your pet. Poop bags are available in office.
- * **Not** allowed in campground buildings, including bathhouses.
- * **Not** allowed to swim in lake or river.
- * **Should** not be left inside RV / tent / vehicle or outside unattended. Barking dogs bother neighbors.
- * **If pet(s)** continually annoys others, you will be asked to leave the campground and no refunds will be given.

FISHING

- * **Lake** / river is for River Ranch paying guests only
- * **Lake** fishing --- 6 am to 8 pm. No fishing day of check-out.
- * **Limit** - 2 fish per day per night's stay. May not catch another camper's limit, including children and babies.
- * **One** fishing rod and one hook per fisherman and rod must be attended to at all times. Absolutely no use of nets to catch fish.
- * **No** catch and release. Keep what you catch or give them away.
- * **No** use of marshmallows, cheese or corn for bait.
- * **No** cleaning of fish in bathhouses. Bag and use dumpsters to discard remains.
- * **If** transporting fish caught from lake, please register fish at office to show compliance with State of New Mexico laws.
- * **River** fishing must comply with NM state fishing laws.
